SFPUC Contract PRO.0104 Southeast Water Pollution Control Plant Program (SEP) Construction Management

(CM) Services

Dear Chair Chan,

In July 2023, during the hearing for File No. 230750, *Professional Services Agreement Modification - Parsons Water & Infrastructure Group, Inc. - Southeast Water Pollution Control Plant Program Construction Management Services - Not to Exceed \$47,000,000, the Budget & Finance Committee requested a follow up regarding future strategies to ensure continued program-level oversight and supervision during the construction of the Sewer System Improvement Program projects following the sunset and closeout of Contract No. PRO.0104 SEP CM Services. This memorandum serves as SFPUC's response to the Budget & Finance Committee's request.*

The scope of the Professional Services Agreement was to facilitate coordination amongst multiple projects at the Southeast Water Pollution Control Plant Phase I. Phase I construction projects are anticipated to be completed by July 2025 with the exception of the Biosolids construction project which has an anticipated completion of 2028. The needs to coordinate amongst multiple projects are no longer required. Considering Phase I construction is nearing completion, the PRO.0104 Professional Services Agreement is no longer needed. Future coordination on projects will be transitioned to SFPUC staff or delivered under other existing or future professional services contracts.

The following construction management support services will be transitioned to SFPUC staff:

- 1. Health & Safety
- 2. Staging and Site Logistics
- 3. Procedural Review of Change Orders
- 4. Construction Contingency Tracking
- 5. Project Controls Support Services
