10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby

12 of San Francisco, et al., San Francisco Superior Court, Case No. CGC-18-568689, by the
13 payment of \$200,000. The lawsuit involves an employment dispute.
