6 WHEREAS, The San Francisco International Airport expansion is one of the largest  
7 public works projects in the United States; and

8 WHEREAS, An estimated five thousand jobs of all wage levels will be available in order  
9 to fully staff the Airport in time for the September 26 opening; and

10 WHEREAS, The types of employment available include baggage and cargo handlers,  
11 administrative, clerical and customer service personnel, custodians, drivers, food servers,  
12 security, retail as well as managerial positions; and

13 WHEREAS, It is the desire of the San Francisco Board of Supervisors that the  
14 International Airport open as scheduled and that many of jobs will be filled by qualified San  
15 Franciscans; and

16 WHEREAS, Unemployment rates are the highest in the Bayview Hunter's Point district  
17 in San Francisco, especially amongst young African American men; and

18 WHEREAS, Transportation from the Bayview Hunter's Point district to the Airport poses  
19 an obstacle for interested and qualified San Franciscans; now, therefore let it be

20 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
21 hereby urges the San Francisco Airport Commission to provide van pools or shuttle services  
22 from a designated location in the Bayview Hunter's Point district in San Francisco to the San  
23 Francisco International Airport's job fair.




