12 File No. 220232 and is incorporated herein by reference; and

17 WHEREAS, This Board has reviewed and considered the subject Tentative Map, the
18 appeal letter, and the other written records before the Board of Supervisors, and heard
19 testimony and received public comment regarding the subject Tentative Map; now, therefore,

22 concerning the Tentative Map and hereby disapproves said Map, subject to the Board of
23 Supervisors' adoption of written findings in support of this determination at a future meeting.
