2 and Urban Development - Community Development Block Grants Coronavirus Program
3 Round 3 Entitlement Grant (CDBG-CV3) - \$9,626,923]

4 **Resolution retroactively approving the CARES Act Community Development Block**
5 **Grant Coronavirus Round 3 (CDBG-CV3) Program; authorizing the Mayor, on behalf of**
6 **the City and County of San Francisco, to apply for, accept, and expend the City’s**
7 **CARES-CV3 program entitlement from the United States Department of Housing and**
8 **Urban Development in the amount of \$9,626,923 for period beginning December 1,**
9 **2020, through June 30, 2023.**

10
11 WHEREAS, Under Title I of the Housing and Community Development Act of 1974, as
12 amended, and related Federal Regulations, the City and County of San Francisco is eligible to
13 apply for and receive a Community Development Block Grant (CDBG); and

14 WHEREAS, The Coronavirus Aid, Relief, and Economic Security Act (CARES Act),
15 Public Law 116-136, was signed into law on March 27, 2020, to respond to the effects of the
16 public health crisis caused by the COVID-19 pandemic; and

17 WHEREAS, The CARES Act allocated \$5 billion in CDBG-CV funds to be used to
18 prevent, prepare for, and respond to COVID-19, of which \$2 billion shall be allocated based
19 on fiscal year 2020 CDBG formula and \$3 billion shall be allocated based on needs in the
20 following tranches: \$1 billion to States and insular areas and \$2 billion to states and local
21 governments; and

22 WHEREAS, San Francisco’s received an award letter for a CDBG-CV allocation based
23 on the fiscal year 2020 CDBG formula for \$10,972,734 (CDBG Round 1 Entitlement); and

24 WHEREAS, San Francisco received an award letter for an Emergency Solutions
25 Grants Coronavirus (ESG-CV) allocation based on the FY2020 Emergency Solutions Grant

1 Program formula for \$5,501,459 (ESG Round 1 Entitlement) and an additional allocation
2 based on a new needs-based formula for \$43,605,003 (ESG Round 2 Entitlement); and

3 WHEREAS, San Francisco received an additional CDBG-CV Round 3 allocation based
4 on a new needs-based formula for \$9,626,923 (CDBG-CV3); and

5 WHEREAS, CDBG-CV eligible uses include rental assistance, eviction prevention
6 services, foreclosure intervention services, capital improvements to community facilities,
7 digital connectivity, financial assistance to small businesses, food programs, and other flexible
8 uses for low and moderate-income individuals, including reimbursement for the costs of
9 eligible activities incurred during the pandemic regardless of date; and

10 WHEREAS, The CARES Act authorizes the Secretary to grant waivers and alternative
11 requirements of statutes and regulations to expedite and facilitate the use of funds to prepare
12 for and respond to COVID-19, including the following flexibilities: may deviate from applicable
13 procurement standards when using these funds to procure goods and services; the availability
14 of a 5-day public comment period for amendments to the Consolidated Plan/Action Plan, and
15 uncaps the percentage of CDBG funding for public services to prevent, prepare for, and
16 respond to coronavirus; and

17 WHEREAS, The CDBG-CV3 expenditure plan was posted on March 16, 2021, and will
18 be open for public comment for five business days; and

19 WHEREAS, The proposed grant does not require an Annual Salary Ordinance
20 amendment; and

21 WHEREAS, The United States Department of Housing and Urban Development (HUD)
22 does not allow use of grant on indirect costs; now, therefore, be it

23 RESOLVED, That the Mayor of the City and County of San Francisco is hereby
24 authorized to retroactively apply for, accept, and expend the City's CDBG-CV3 funds from
25 HUD and expend \$9,626,923 in accordance with the purposes and goals for the funding as

1 generally set forth in 2020-2024 Five Year Consolidated Plan and the Expenditure Schedule;
2 and, be it

3 FURTHER RESOLVED, That the Board of Supervisors does hereby approve the
4 purposes and goals for CDBG-CV3 funding as set forth in the Expenditure Schedule for
5 recipient agencies and departments; and, be it

6 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
7 indirect costs in the grant budget; and, be it

8 FURTHER RESOLVED, That the Mayor is hereby authorized to enter into and execute
9 agreements between the City and County of San Francisco and various agencies consistent
10 with CDBG-CV3 Expenditure Schedule; and, be it

11 FURTHER RESOLVED, That the Mayor is hereby authorized to submit documentation
12 and certifications as may be requested or required by HUD, and to take such additional
13 actions as may be required to apply for, accept and expend the CDBG-CV3 funds consistent
14 with this Resolution and the goals of the CDBG-CV3 Program and all applicable legal
15 requirements, and any such actions are solely intended to further the purposes of this
16 Resolution, and are subject in all respect to the terms of this Resolution, and any such action
17 cannot increase the risk to the City, or require the City to expend any resources, and that the
18 Mayor shall consult with the City Attorney prior to execution and provided that within 30 days
19 of the agreements approved by this Resolution being executed by all parties, such final
20 documents (showing marked changes, if any) shall be provided to the Clerk of the Board, for
21 inclusion in the official file, together with a brief explanation of any actions from the date of the
22 adoption of this Resolution; and, be it

23 FURTHER RESOLVED, That all actions heretofore taken by the officers of the City
24 with respect to the application for, or the acceptance or expenditure of CDBG-CV3 funds as
25

1 consistent with the documents herein and this Resolution, are hereby approved, confirmed
2 and ratified.

Dear Mayor Breed:

I am pleased to inform you of a special allocation to your jurisdiction of Community Development Block Grant funds to be used to prevent, prepare for, and respond to the coronavirus (COVID-19). This allocation was authorized by the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), Public Law 116-136, which was signed by President Trump on March 27, 2020, to respond to the growing effects of this historic public health crisis.

The CARES Act made available \$5 billion in Community Development Block Grant Coronavirus (CDBG-CV) funds. Of this amount, the Department immediately allocated \$2 billion on March 27, 2020, the same day President Trump signed the Act, based on the fiscal year 2020 CDBG formula; this constituted the first round of CDBG-CV funds. Next, \$1 billion was required by the Act to be allocated to States and insular areas within 45 days of enactment of the Act; HUD accomplished this on May 11, 2020, and this constituted the second round of CDBG-CV funds. Finally, the remaining \$2 billion in CDBG-CV funds was required by the Act to be allocated to states and local governments at the discretion of the Secretary on a rolling basis; HUD accomplished this on September 11, 2020, and this constituted the third round of CDBG-CV funds. Additionally, up to \$10 million will be set aside for technical assistance.

Accordingly, this letter informs you that your jurisdiction's allocation for the third round is \$9,626,923. Your cumulative amount for all allocation rounds is \$20,599,657.

The CARES Act adds additional flexibility for both the CDBG-CV grant and, in some cases, for the annual FY2019 and FY2020 CDBG grants in these unprecedented times. The public comment period is reduced to not less than 5 days, grantees may use virtual public hearings when necessary for public health reasons, the public services cap is suspended during the emergency, and States and local governments may reimburse costs of eligible activities incurred for pandemic response regardless of the date.

In addition, the CARES Act authorizes the HUD Secretary to grant waivers and alternative requirements of statutes and regulations the HUD Secretary administers in connection with the use of CDBG-CV funds and fiscal year 2019 and 2020 CDBG funds (except for requirements related to fair housing, nondiscrimination, labor standards, and the environment). Waivers and alternative

requirements can be granted when necessary to expedite and facilitate the use of funds to prevent, prepare for, and respond to coronavirus.


The CDBG CARES Act Federal Register Notice (FR-6218-N-01) was released on August 10, 2020. The notice describes the allocations and grant procedures applicable to the CDBG-CV grants. It also describes the program flexibilities, waivers, and alternative requirements that apply to the CDBG-CV grants as well as the fiscal year 2019 and 2020 CDBG grants. As further such flexibilities become available, they will be posted on HUD's website and distributed to grantees. The Department will also support grantees with technical assistance.

As you develop your plan for the use of these grant funds, we encourage you to consider approaches that prioritize the unique needs of low- and moderate-income persons and the development of partnerships between all levels of government and the private for-profit and non-profit sectors. You should coordinate with state and local health authorities before undertaking any activity to support state or local pandemic response. CDBG-CV grants will be subject to oversight, reporting, and the requirement that each grantee have adequate procedures to prevent the duplication of benefits (DOB). HUD will provide guidance and technical assistance on DOB, the prevention of fraud, waste, and abuse, and on documenting the impact of this program for beneficiaries.

Reminder, all CPD Grantees must ensure they maintain active Dun and Bradstreet Numbering System (DUNS) numbers in the System for Award Management (SAM) system. Entities must have an active and unexpired DUNS before execution of grant agreements to avoid delays in the obligation of funds- which will delay your ability to drawdown funds in the Integrated Disbursement & Information System (IDIS). Grantees are required to maintain an active SAMs registration by re-activating their DUNS number annually in the SAM system for the entire drawdown period of their grants.
