2 AUTHORIZING THE DEPARTMENT OF ADMINISTRATIVE SERVICES TO ENTER INTO  
3 AN AGREEMENT WITH THE STATE OF CALIFORNIA AND TO ACCEPT \$74,000 FROM  
4 THE STATE OF CALIFORNIA TO IMPLEMENT A PLAN TO ACHIEVE A COMPLETE AND  
5 ACCURATE COUNT FOR THE CENSUS 2000

7 WHEREAS, The California State Legislature passed legislation to establish the  
8 California Complete Count Committee to maximize the number of Californians counted in the  
9 Census 2000 and to implement a census outreach program; and,

10 WHEREAS, The California Budget Bill for 1999-2000 included an appropriation of  
11 \$5,000,000 to administer the activities of the County Complete Count Committees; and,

12 WHEREAS, The State of California has appropriated \$74,000 to enhance the City's  
13 outreach effort to increase the return of census forms by people residing in the City and  
14 County of San Francisco; and,

15 WHEREAS, The Department of Administrative Services desires to enter into an  
16 Agreement (the "Agreement") with the State of California to accomplish these goals, in  
17 substantially the form as the agreement on file with the Clerk of the Board of Supervisors in  
18 File No. 000399; now, therefore, be it

19 RESOLVED, That the Board of Supervisors authorizes the Department of  
20 Administrative Services to accept the terms of the Agreement and \$74,000 from the State of  
21 California; and be it

22 FURTHER RESOLVED, That a copy of this resolution will be forwarded to the  
23 California Complete Count Committee with a request that they take all action necessary to  
24 achieve the objectives of this resolution.


