

1 (PUBLIC TRANSPORTATION)

2 APPROVING AN AGREEMENT BETWEEN THE CITY AND COUNTY OF SAN  
3 FRANCISCO AND THE BAY AREA RAPID TRANSIT DISTRICT AUTHORIZING  
4 PAYMENT TO SAN FRANCISCO MUNICIPAL RAILWAY FOR TRANSFER TRIPS  
5 PROVIDED IN ~~FY98~~, 1997-1998.

6  
7 WHEREAS, The Municipal Railway's FY98 budget included a payment from BART  
8 estimated at \$1,751,358; and

9  
10 WHEREAS, That payment is based on a historical agreement whereby BART agrees to  
11 annually reimburse MUNI to recognize that many BART patrons use MUNI to link up with their  
12 BART trips, and that these patrons would not take BART at all were it not for the MUNI link;  
13 and

14  
15 WHEREAS, Historically BART has based its payment to MUNI on the prior year's  
16 payment with adjustments for changes in BART sales tax revenues; and

17 WHEREAS, Approval of the annual payment has been done on an annual basis; and

18  
19 WHEREAS, MUNI and BART staff have agreed that the amount due to MUNI for ~~FY98~~ <sup>1997-1998</sup>  
is \$1,934,563; and

20  
21 WHEREAS, On DEC 08 1998 the Public Transportation Commission adopted  
22 Resolution No. 98 - 113, authorizing the Director of Public Transportation to execute an  
23 agreement with BART concerning the ~~FY98~~ <sup>1997-1998</sup> transfer payment from BART to MUNI; and

1           **WHEREAS**, The Board of Supervisors has reviewed the proposed agreement, and  
2 determined that BART's annual payment to MUNI increases MUNI's ability to provide feeder  
3 bus transit service to BART stations, thus encouraging transit use and benefiting patrons of both  
4 BART and MUNI; now, therefore be it

5           **RESOLVED**, That the Board of Supervisors hereby authorizes the General Manager of  
6 Public Transportation to execute the attached Agreement with BART to effect the FY<sup>1997-1998</sup> payment  
/19/997 from BART to MUNI.


