5 WHEREAS, Francesca Vietor has been a prominent leader among  
6 environmental agencies in San Francisco over the last fifteen  
7 years, serving on both the Commission on the Environment and as  
8 the Director of the Department of the Environment; and,

9 WHEREAS, Francesca Vietor has completed her work at the  
10 Department of the Environment after four years as the Director  
11 of the agency; and,

12 WHEREAS, During her tenure, Francesca Vietor lead the  
13 Department of the Environment to many successful accomplishments  
14 which will create a cleaner, healthier and more sustainable San  
15 Francisco; and,

16 WHEREAS, Among these accomplishments are the Department's  
17 elimination of the most toxic pesticides used in San Francisco  
18 and a reduction of overall pesticide use by 50%, ten new green  
19 building pilot projects, acquiring over 300 zero and low  
20 emission vehicles for San Francisco's fleet, banning the sale of  
21 mercury thermometers and exchanging 5,000 mercury thermometers  
22 for digital thermometers, and growing the Department from a  
23 staff of two with a budget of \$250,000 to a staff of 15 with a


