3 **Ordinance authorizing settlement of the lawsuit filed by Jack K. Frazier against the City**
4 **and County of San Francisco for \$4,990,000; the lawsuit was filed on October 28, 2013,**
5 **in San Francisco Superior Court, Case No. CGC-13-535089; entitled Jack K. Frazier v.**
6 **City and County of San Francisco, et al.; the lawsuit involves personal injury due to**
7 **collision with fire truck; other material terms of the settlement are that defendant**
8 **Michael Quinn pay plaintiff \$10,000.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled Jack K. Frazier v. City and County of
13 San Francisco, San Francisco Superior Court, Case No. CGC-13-535089 by the payment of
14 \$4,990,000 and defendant Michael Quinn to pay plaintiff \$10,000. The lawsuit involves
15 personal injury due to collision with fire truck.

16 Section 2. The above-named action was filed in San Francisco Superior Court on
17 October 28, 2013, and the following parties were named in the lawsuit: Plaintiff Jack K.
18 Frazier and Defendants City and County of San Francisco and Michael Quinn.
