3 **Ordinance authorizing settlement of the lawsuit filed by Devaughn Frierson against the**
4 **City and County of San Francisco for \$29,500; the lawsuit was filed on June 9, 2015, in**
5 **the United States District Court, Case No. 15-cv-02573; entitled Devaughn Frierson v.**
6 **City and County of San Francisco, et al.; the lawsuit involves alleged civil rights**
7 **violations; other material terms of the settlement are the dismissal of all defendants.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Devaughn Frierson v. City and County
12 of San Francisco, et al., United States District Court, Case No. 15-cv-02573 by the payment of
13 \$29,500 and dismissal of all defendants. The lawsuit involves alleged civil rights violations.

14 Section 2. The above-named action was filed in United States District Court on June 9,
15 2015, and the following parties were named in the lawsuit: Plaintiff Devaughn Frierson;
16 Defendants City and County of San Francisco and Officer Antonio Carrasco.






