Ordinance authorizing settlement of the lawsuit filed by Devaughn Frierson against the City and County of San Francisco for \$29,500; the lawsuit was filed on June 9, 2015, in the United States District Court, Case No. 15-cv-02573; entitled <u>Devaughn Frierson v.</u>

<u>City and County of San Francisco, et al.</u>; the lawsuit involves alleged civil rights violations; other material terms of the settlement are the dismissal of all defendants.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Devaughn Frierson v. City and County of San Francisco</u>, et al., United States District Court, Case No. 15-cv-02573 by the payment of \$29,500 and dismissal of all defendants. The lawsuit involves alleged civil rights violations.

Section 2. The above-named action was filed in United States District Court on June 9, 2015, and the following parties were named in the lawsuit: Plaintiff Devaughn Frierson; Defendants City and County of San Francisco and Officer Antonio Carrasco.
