WHEREAS, The Board may elect a new President in advance of the vacancy, and if the Board chooses to do so, the elected Supervisor would assume the Office of President upon Supervisor Chiu's resignation as a Supervisor and would serve as President until the expiration of the term at 12:00 p.m. on January 8, 2015; now, therefore, be it
