Be it ordained by the People of the City and County of San Francisco:

Section 1. Findings. The Board of Supervisors of the City and County of San Francisco hereby finds and determines that:

(a) On February 22, 2006, the Planning Department issued a Final Mitigated Negative Declaration encompassing this Zoning Map Amendment, on file with the Department (File No. 2004.0852E), in compliance with the California Environmental Quality Act ("CEQA") (California Public Resources Code section 21000 et seq.), the State CEQA Guidelines (California Code of Regulations Title 14 sections 15000 et seq.) and Chapter 31 of the San Francisco Administrative Code ("Chapter 31"). The Negative Declaration was prepared for a proposed residential project with ground floor retail space and underground parking at One Hawthorne Street ("Project"). The Planning Commission adopted Motion No. 17211 and Resolution No. 17213 adopting findings related to a determination of compliance with CEQA for the Project and the Zoning Map Amendment, and this Board of Supervisors

hereby affirms and adopts said findings based on the reasons set forth therein, and incorporates such reasons by reference.

- (b) On March 23, 2006 the Planning Commission held a duly noticed public hearing and in Resolution No. 172/3, the Planning Commission approved and recommended adoption by the Board of an amendment to the Zoning Map of the City and County of San Francisco to change the Height and Bulk classification for Block 3735, Lot 047 from 150-S to 250-S.
- (d) Pursuant to Planning Code Section 101.1, this Board of Supervisors finds that this Zoning Map Amendment is consistent with the priority policies of Section 101.1(b) of the Planning Code and the General Plan, and hereby adopts the findings of the Planning Commission, as set forth in Planning Commission Motion Nos. 17215 and 17214, and Planning Commission Resolution No. 17213, and incorporates said findings by reference herein.
- Section 2. Pursuant to Sections 106 and 302(c) of the Planning Code, the following change in height classification, duly approved and recommended to the Board of Supervisors

by the Planning Commission, is hereby adopted as an amendment to Zoning Map Sheet IH of the City and County of San Francisco.
