10 Be it ordained by the People of the City and County of San Francisco:


11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled Emmett Waldrip, an incompetent, by
13 Dixie Waldrip, his conservator of the estate v. City and County of San Francisco, San
14 Francisco Superior Court, Case No. CGC-17-562069 by the payment of \$125,000. The
15 lawsuit involves alleged medical negligence.

16 Section 2. The above-named action was filed in San Francisco Superior Court on
17 October 23, 2017, and the following parties were named in the lawsuit: Plaintiffs: Emmett
18 Waldrip, an incompetent, by Dixie Waldrip, his conservator of the estate; Defendant: City and
