

1 [Urging Voter Registration Assistance]

2 URGING ALL SAN FRANCISCO CITY DEPARTMENTS AND COMMISSIONS TO HELP  
3 STATE-FUNDED NON-PROFIT ORGANIZATIONS THAT PROVIDE SERVICES TO  
4 PEOPLE WITH DISABILITIES REGISTER THEIR CLIENTS TO VOTE IN ACCORDANCE  
5 WITH THE NATIONAL VOTER REGISTRATION ACT OF 1993.

7 WHEREAS, The National Voter Registration Act of 1993 (NVRA) was passed with the  
8 intent of increasing the number of registered voters in Federal elections throughout the United  
9 States; and,

10 WHEREAS, The NVRA requires states to designate state-funded organizations that  
11 are primarily engaged in providing services to persons with disabilities as voter registration  
12 agencies; and,

13 WHEREAS, Examples of such agencies include, but are not limited to, organizations  
14 involved in vocational rehabilitation and special education, commissions for the deaf and the  
15 blind, para-transit providers, independent living centers, and disability-specific service  
16 providers; and,

17 WHEREAS, The services to be provided by these agencies include voter registration  
18 of their clients during the application, intake, re-certification, change-of-address and/or  
19 orientation process; and,

20 WHEREAS, The City and County of San Francisco contracts with a large number of  
21 such organizations that are not currently providing these required services;

22 WHEREAS, Such services would empower an often neglected group of voters,  
23 increase the representation of persons with disabilities in the electorate and reinforce their  
24 role in the democratic process; now, therefore be it

25 RESOLVED, That the City and County of San Francisco Board of Supervisors hereby

1 urges all San Francisco City Departments and Commissions to help state-funded non-profit  
2 organizations that provide services to people with disabilities register their clients to vote in  
3 accordance with the National Voter Registration Act of 1993.


