3	Ordinance authorizing settlement of the lawsuit filed by Tessa Luu against the City and
4	County of San Francisco for \$864,282, comprised of a payment of \$730,000 and the
5	forgiveness of the City's lien in the amount of \$134,282; the lawsuit was filed on
6	September 2, 2020, in San Francisco Superior Court, Case No. CGC-20-586519; entitled
7	Tessa Luu v. City and County of San Francisco; the lawsuit involves an alleged
8	personal injury on a City sidewalk.

10	Be it ordained by the People of the City and County of San Francisco:
11	Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
12	authorizes the City Attorney to settle the action entitled <u>Tessa Luu v. City and County of San</u>
13	Francisco, San Francisco Superior Court, Case No. CGC-20-586519 by the payment of
14	\$730,000 to Plaintiff and forgiveness of the City's \$134,282 lien against Plaintiff. The lawsuit
15	involves an alleged personal injury on a City sidewalk.
16	Section 2. The above-named action was filed in San Francisco Superior Court on
17	September 2, 2020, and the following parties were named in the lawsuit: Plaintiff: Tessa Luu;
