3 **Resolution authorizing the San Francisco Port Commission to accept and expend a**
4 **grant in the amount of \$143,200 from the State of California San Francisco Bay Natural**
5 **Resources Protection Trust for the Pier 94 Wetlands Enhancement Project.**

7 WHEREAS, the Pier 94 Wetlands Enhancement Project ("Pier 94 Project") will
8 enhance existing wetlands in accordance with the Southern Waterfront Supplemental
9 Environmental Impact Report (SEIR); and,

10 WHEREAS, the San Francisco Bay Natural Resources Protection Trust ("Trust") is
11 responsible for supporting environmental enhancement projects in areas within the City and
12 County of San Francisco that were adversely impacted by oil released from the SS Cape
13 Mohican oil spill and the Pier 94 Project qualified for grant assistance from the Trust; and,

14 WHEREAS, the San Francisco Port Commission, approved Resolution 02-65 at its
15 meeting December 17, 2002, authorizing the Port's Executive Director to accept One Hundred
16 Forty -Three Thousand Two Hundred dollars in Trust grant funds for the Pier 94 Project,
17 subject to Board of Supervisors' approval; and,

18 WHEREAS, The Department proposes to maximize use of available grant funds on
19 program expenditures by not including indirect costs in the grant budget; now, therefore, be it

20 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in
21 the grant budget; and, be it

22 FURTHER RESOLVED, That the Board of Supervisors authorizes the San Francisco
23 Port Commission to accept and expend One Hundred Forty -Three Thousand Two Hundred
24 dollars (\$143,200) from the San Francisco Bay Natural Resources Protection Trust; and, be it




