ORDINANCE NO. 270-05

1 [Parking Restrictions.]

3 Ordinance amending the San Francisco Traffic Code by amending Section 3.6.1 to
4 redefine the Downtown Core area, by amending 38.B to prohibit no stopping except for
5 the loading or unloading of passengers or freight in the Downtown Core, by amending
6 38.B.1 to prohibit no stopping except for the loading or unloading of passengers or
7 freight outside of the Downtown Core, by amending 201.1 to revise the boundaries for
8 Parking Meter Area Number One, and by amending 201.2 to revise the boundaries for
9 Parking Meter Area Number Two.

13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The San Francisco Traffic Code is hereby amended by amending Sections
15 3.6.1, 38.B, 38.B.1, 201.1, 201.2, to read as follows:

16 **SEC. 3.6.1. DOWNTOWN CORE.**

17 That area of San Francisco encompassed by and including ~~Washington Street on the~~
18 ~~north, Stockton Street and 4th Street on the west, King Street on the south and The Embarcadero on the~~
19 ~~east~~ Parking Meter Areas One and Two defined in Sections ^{201.1} ~~201.1~~ and 201.2.

20 **SEC. 38.B. CURB PARKING REGULATIONS - YELLOW ZONES - ~~METROPOLITAN~~**
21 **TRAFFIC DISTRICT DOWNTOWN CORE.**

22 No person shall stop, except for the purpose of loading or unloading passengers or
23 freight, in a yellow curb marking within the ~~Metropolitan Traffic Distriet~~ Downtown Core between
24 the hours of 7:00 a.m. and 6:00 p.m., or in such yellow curb marking where a different period
25 has been designated and signs posted apprising persons of such change, on any day except

1 Sundays, in excess of a period of three minutes for passenger vehicles or a period ranging
2 from 15 minutes to two hours, as designated by the Director of Parking and Traffic, for
3 commercial vehicles. Passenger vehicles shall not be stopped in yellow zones under any
4 circumstances between the hours specified or as designated except while the operator is in
5 attendance.

6 In parking meter areas, the zones shall be posted with signs giving notice of the
7 stopping, standing and parking restrictions effective in the zone, and shall have parking
8 meters permitting a maximum parking time ranging from 15 minutes to two hours, as
9 designated by the Director. Denomination of the coin or coins that shall be deposited in these
10 parking meters, the parking time allowed following deposit of such coins, and the hours during
11 which such deposits are required shall be those set for all other parking meters in the same
12 parking meter area or areas.

13 **SEC. 38.B.1. CURB PARKING REGULATIONS - YELLOW ZONES - OUTSIDE**
14 **ZONES - ~~METROPOLITAN TRAFFIC DISTRICT~~ DOWNTOWN CORE.**

15 No person shall stop, except for the purpose of loading or unloading passengers or
16 freight, in a yellow curb marking outside of the ~~Metropolitan Traffic District~~ Downtown Core
17 between the hours of 8:00 a.m. and 6:00 p.m., or in such yellow curb marking where a
18 different period has been designated and signs posted apprising persons of such change, on
19 any day except Sundays, in excess of a period of three minutes for passenger vehicles or a
20 period ranging from 15 minutes to two hours, as designated by the Director of Parking and
21 Traffic for commercial vehicles. Passenger vehicles shall not be stopped in yellow zones
22 under any circumstances between the hours specified or as designated except while the
23 operator is in attendance.

1 In parking meter areas, the zones shall be posted with signs giving notice of the
2 stopping, standing and parking restrictions effective in the zone, and shall have parking
3 meters permitting a maximum parking time ranging from 15 minutes to two hours, as
4 designated by the Director. Denomination of the coin or coins that shall be deposited in these
5 parking meters, the parking time allowed following deposit of such coins, and the hours during
6 which such deposits are required shall be those set for all other parking meters in the same
7 parking meter area or areas.

8 **SEC. 201.1. PARKING METER AREA NUMBER ONE.**

9 Parking Meter Area Number One shall include that portion of the City and County of
10 San Francisco commencing at a point where the southerly line of ~~Howard Street~~King Street
11 intersects the easterly line of The Embarcadero, thence westerly along the southerly line of
12 ~~Howard Street~~King Street to the westerly line of ~~Third Street~~Fourth Street, thence northerly along
13 the westerly line of ~~Third Street~~Fourth Street to the northerly line of Mission Street, thence
14 westerly along the northerly line of Mission Street to the westerly line of Seventh Street,
15 thence northerly along the westerly line of Seventh Street to the northerly line of Market
16 Street, thence easterly along the northerly line of Market Street to the westerly line of Taylor
17 Street, thence northerly along the westerly line of Taylor Street to the northerly line of Bush
18 Street, thence easterly along the northerly line of Bush Street to the easterly line of Grant
19 Avenue, thence northerly along the easterly line of Grant Avenue to the northerly line of
20 California Street, thence easterly along the northerly line of California Street to the westerly
21 line of Kearny Street, thence northerly along the westerly line of Kearny Street to the southerly
22 line of Jackson Street, thence easterly along the southerly line of Jackson Street to the
23 easterly line of Battery Street, thence southerly along the easterly line of Battery Street to the
24 northerly line of Washington Street, thence easterly along the northerly line of Washington


1 Street to the easterly line of The Embarcadero, thence southerly along the easterly line of The
2 Embarcadero to the point of commencement.

3 **SEC. 201.2. PARKING METER AREA NUMBER TWO.**

4 Parking Meter Area Number Two shall consist of that portion of the City and County of
5 San Francisco commencing at a point where the northerly line of Folsom Street intersects the
6 westerly line of ~~The Embarcadero~~ Fifth Street, thence westerly along the northerly line of Folsom
7 Street to the westerly line of Tenth Street, thence northerly along the westerly line of Tenth
8 Street to the southerly line of Mission Street, thence westerly along the southerly line of
9 Mission Street to the westerly line of Twelfth Street, thence northerly along the westerly line of
10 Twelfth Street to the northerly line of Market Street, thence westerly along the northerly line of
11 Market Street to the westerly line of Franklin Street, thence northerly along the westerly line of
12 Franklin Street to the northerly line of Eddy Street, thence easterly along the northerly line of
13 Eddy Street to the westerly line of Jones Street, thence northerly along the westerly line of
14 Jones Street to the northerly line of Bush Street, thence easterly along the northerly line of
15 Bush Street to the westerly line of Stockton Street, thence northerly along the westerly line of
16 Stockton Street to the southerly line of Broadway, thence easterly along the southerly line of
17 Broadway to the westerly line of The Embarcadero, thence southerly along the westerly line of
18 The Embarcadero to the southerly line of King Street, thence along the southerly line of King Street
19 to the westerly line of Fifth Street, thence northerly along the westerly line of Fifth Street to the point
20 of commencement, except that the portion of the City and County of San Francisco within
21 Parking Meter Area Number One as described in Section 201.1 is excluded from Parking
22 Meter Area Number Two.
