7 WHEREAS, The City and County of San Francisco, through the adoption and  
8 implementation of the Healthy Air and Smog Prevention Ordinance, mandates that municipal  
9 fleet purchases be low emission vehicles; and,

10 WHEREAS, The City and County of San Francisco's Department of the Environment's  
11 Clean Air Program adopted a primary mission to reduce automobile emissions through  
12 programs that promote trip reduction, transit incentives and environmentally friendly vehicles;  
13 and,

14 WHEREAS, The City College of San Francisco has recently endorsed the concept of a  
15 Regional Transportation Center in order to attract prospective students, and expand its  
16 Workforce and Economic Development and Trade Skills curriculum at the Southeast Campus  
17 located on Evans Street; and,

18 WHEREAS, The City and County of San Francisco supports projects that are designed  
19 to provide training and the creation of new jobs, particularly in areas that have been  
20 historically low-income neighborhoods; and,

21 WHEREAS, The City and County of San Francisco supports the development of  
22 businesses that advance sustainability and are environmentally sensitive; and,

23 WHEREAS, The City and County of San Francisco supports businesses that increase  
24 its tax base; now, therefore, be it

1           RESOLVED, That the City and County of San Francisco Board of Supervisors does  
2 hereby support the concept of and officially endorse the development of a Regional  
3 Transportation Center, a project designed to improve the air quality through the education and  
4 greater adoption of Alternative Fuel Vehicles by the general public.




