3 **Resolution designating the San Francisco Independent to be the official newspaper of**
4 **the City and County of San Francisco for the category of non-consecutive day official**
5 **advertising, for the period commencing January 1, 2003 and ending June 30, 2003.**

7 WHEREAS, in each year, the Board of Supervisors shall designate the official
8 newspaper of the City and County of San Francisco, pursuant to Article IX, Section 2.80-1 and
9 2.81 of the San Francisco Administrative Code;

10 WHEREAS, the Finance Committee, at the meeting of November 6, 2002, approved
11 release of reserved funds, Board of Supervisors fiscal year 2002-2003 budget, in the amount
12 of \$288,200 for the continuation of the Official Advertising contract with the San Francisco
13 Independent for the period January 1, 2003 through June 30, 2003, now therefore, be it

14 RESOLVED, that the San Francisco Independent, a newspaper of general circulation
15 published in the City and County of San Francisco for the dissemination of local or telegraphic
16 news and intelligence of a general character, having a bona fide circulation of at least 50,000
17 copies per calendar week, printed in the City and County on three or more days in a calendar
18 week, is hereby designated as an official newspaper of the City and County of San Francisco,
19 commencing January 1, 2003 for the publication of all official advertising of the City and
20 County which is required by law, other than the provisions of Section 2.103 of the Charter as
21 they relate to special meetings of the Board of Supervisors and its special or standing
22 committees, to be published one time, and all official advertising of the City and County which
23 is required by law to be published more than one, but not more than three times per week for
24 a specified number of weeks, and, be it

1 FURTHER RESOLVED, that the Office of Contract Administration is hereby authorized
2 to execute a contract with the San Francisco Independent and said contract must be in
3 accordance with all the contracting requirements of the City and County of San Francisco.
