3 **Resolution authorizing the San Francisco Department of Public Health, Community**
4 **Behavioral Health Services (SFDPH,CBHS) to enter retroactively into a Combined**
5 **Negotiated Net Amount and Drug Medi-Cal Agreement with the State of California**
6 **Department of Alcohol and Drug Programs (DADP) for the term of July 1, 2004,**
7 **through June 30, 2008 in the amount of \$57,686,688 and for the term of July 1, 2004**
8 **through June 30, 2005 in the amount of \$19,228,896 as a condition of receiving state**
9 **funds and Drug Medi-Cal reimbursement for substance abuse treatment and**
10 **prevention; holding DADP harmless from any and all claims resulting from the**
11 **agreement; authorizing and designating the Director of SFDPH,CBHS to sign said**
12 **Agreement and to approve amendments for less than ten percent (10%) of the**
13 **contracted amount.**

15 WHEREAS, Approval of the Combined Negotiated Net Amount and the Drug Medi-
16 Cal Agreement between DADP and SFDPH,CBHS would (1) enable the City to accept
17 DADP's FY 2004-05 funding allocation, or NNA, for the provision of substance abuse services
18 in San Francisco, and (2) authorize the DADP to encumber Drug Medi-Cal funds for the
19 purpose of reimbursing the City for Drug Medi-Cal services provided by SFDPH,CBHS's
20 service providers in FY 2004-05, for a combined total amount of \$19,228,896; and,

21 WHEREAS, The Agreement includes a hold harmless clause which provides that the
22 City will hold the State harmless from (1) any claims and losses resulting to contractors,
23 subcontractors, individuals, firms and corporations furnishing or supplying work services,
24 materials, or supplies in connection to the performance of this contract and (2) any claims and

1 losses resulting to any person, firm, or corporation who may be injured or damaged in
2 connection to the City's performance of this contract; and,


3 WHEREAS, The Director of SFDPH, CBHS is designated to sign the Combined
4 Negotiated Net Amount and Drug Medi-Cal Agreement and approve future amendments for
5 less than ten percent (10%) of the contracted amount; now, therefore, be it

6 RESOLVED, That SFDPH, CBHS is hereby authorized to enter into a Combined
7 Negotiated Net Amount and Drug Medi-Cal Agreement with DADP for the term of July 1, 2004
8 through June 30, 2008 in the amount of \$57,686,688 and for the term of July 1, 2004 through
9 June 30, 2005 in the amount of \$19,228,896 as a condition of receiving State funds and Drug
10 Medi-Cal reimbursement for substance abuse treatment and prevention; and, be it


11 FURTHER RESOLVED, That said Agreement shall include an indemnification of the




