3 **Resolution appointing Renu Nanda, term ending December 31, 2005 to the Child Care**
4 **Planning and Advisory Council. Residency requirement waived.**

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
7 does hereby appoint the hereinafter designated person to serve as a member of the Child
8 Care Planning and Advisory Council, pursuant to the provisions of the San Francisco
9 Administrative Code, Section 5.200, and California Education Code, Sections 8499-8499.8,
10 for the term specified:

11 Renu Nanda, (residency requirement waived) succeeding Marie Lee, resigned, Seat
12 No. 3, must be a nominee of District 3 Supervisor selected from: parent advisory councils of
13 public and private child care programs; associations of child care centers, family day care
14 providers and Head Start; public interest organizations including but not limited to the Child
15 Care Law Center; community organizations; the Bay Area Employer Work and Family
16 Coalition; and members of labor organizations and local organizations that fall within the
17 definition of "Community representative"; for the unexpired portion of a 3-year term ending
18 December 31, 2005.

19 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 20 1. The membership of the Child Care Planning and Advisory Council has a goal to be
21 representative of the diversity of the City and County of San Francisco.
- 22 2. Applicant Renu Nanda, a new appointee, who is not a resident of San Francisco, is
23 a person with experience that uniquely qualifies him/her to serve on the Child Care
24 Planning and Advisory Council.

1 3. The Child Care Planning and Advisory Council has attempted to fill the position, for
2 which Renu Nanda was nominated, with an individual who is a City resident and
3 who has the specific experience, skills, and qualifications, but has been unable to
4 do so at this time. The Rules Committee has certified that Renu Nanda is qualified
5 to serve on the Child Care Planning and Advisory Council.

6 4. After exercising due diligence, the Board of Supervisors concludes that there is no
7 other possible representative, who is a resident of San Francisco and who has the
8 specific experience, skills, or qualifications possessed by this applicant, and who is
9 willing to serve on the Child Care Planning and Advisory Council at this time; and,
10 be it

11 FURTHER RESOLVED, That the Board of Supervisors waives the residency
12 requirement for Renu Nanda, as allowed in cases where no qualified City resident, willing to
13 serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)
14 appointed to boards, commissions, and advisory bodies established by legislative act of the
15 Board of Supervisors to be resident(s) of the City and County of San Francisco.


