3 **Ordinance authorizing settlement of the lawsuit filed by Yvonne Detert, et al. against**
4 **the City and County of San Francisco, et al. for \$137,785.78, plus statutory interest; the**
5 **lawsuit was filed on September 21, 2018, in San Francisco Superior Court, Case**
6 **No. CGC-18-570011; entitled Yvonne Detert, et al. v. City and County of San Francisco,**
7 **et al.; the lawsuit involves a claim of refund of penalties related to hotel taxes and fees**
8 **for tax periods October 1, 2013, through and including December 31, 2013.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled Yvonne Detert, et al. v. City and
13 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-18-570011 by
14 the payment of \$137,785.78, plus statutory interest. The lawsuit involves a claim of refund of
15 penalties related to hotel taxes and fees for tax periods October 1, 2013, through and
16 including December 31, 2013.

17 Section 2. The above-named action was filed in San Francisco Superior Court on
18 September 21, 2018, and the following parties were named in the lawsuit: Plaintiffs Yvonne
19 Detert, Engage Hospitality LLC, KPH Management LLC, and AGPME Tenant LLC;
20 Defendants City and County of San Francisco and Jose Cisneros.
