8 Be It Ordained by the People of the City and County of San Francisco:

9 **SECTION 1.** Under and pursuant to the laws of the State of California and in conformity
10 therewith a tax is hereby levied for City and County purposes, for the fiscal year ending June 30,
11 2000, on all property, real and personal, in the City and County of San Francisco, except such
12 property as is by law exempt from taxation, in the sum of one dollar, three and sixty hundred
13 twenty-two thousandths, eight hundred forty-three millionths cents (\$1.03622843) on each one
14 hundred dollars valuation of said taxable property as the same appears upon the secured
15 assessment roll of the said City and County for said fiscal year, which said sum as aforesaid is
16 hereby apportioned in accordance with the provisions of Section 18.103 of the Charter to the
17 funds and accounts and for the purpose designated as follows:

20 For the General Fund to meet the expenses of the City and County of San Francisco not subject
21 to said limitations of Section 18.103 of the Charter, including the cost of elections, the
22 construction, maintaining and improving of streets, sewers and buildings, parks, squares,
23 playgrounds and libraries, obligations imposed by the State Legislative or Constitutional
