4 **City and County of San Francisco for \$500,000; the lawsuit was filed on December 16,**
5 **2013, in United States District Court-Northern District of California, Case No. 13-cv-**
6 **05820; entitled Vincent Keith Bell v. Ken Lee, et al.; the lawsuit involves alleged civil**
7 **rights violation.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Vincent Keith Bell v. Ken Lee, et al.,
12 United States District Court-Northern District of California, Case No. 13-cv-05820 by the
13 payment of \$500,000. The lawsuit involves an alleged civil rights violation.

14 Section 2. The above-named action was filed in United States District Court-Northern
15 District of California on December 16, 2013, and the following parties were named in the
16 lawsuit: Plaintiff: Vincent Keith Bell; Defendants: City and County of San Francisco, Denny
17 Lee #2131, Christopher Krol #1412, Michael Gatmen #1944, Robin De Los Reyes #2016,
