3	Resolution reaffirming San Francisco's commitment to the Administrative Code,
4	Chapter 14B Local Business Enterprise (LBE) program.

6	WHEREAS, San Francisco is one of the greatest cities in the world, renowned for its
7	innovation, diversity, and economic strength, and remains committed to fostering a thriving
8	local business community; and
9	WHEREAS, The Local Business Enterprise (LBE) Program was established under
10	Chapter 14B of the San Francisco Administrative Code to ensure that small and
11	disadvantaged businesses have fair and equitable access to City contracts and procurement
12	opportunities; and
13	WHEREAS, The LBE Program aims to promote economic vitality by increasing
14	participation from local businesses, particularly those owned by minorities, women, and
15	disadvantaged groups, in public contracting; and
16	WHEREAS, Local Business Enterprises (LBEs) are integral to the economic and social
17	fabric of San Francisco, providing essential goods, services, and employment opportunities to
18	local residents while reinforcing the City's reputation as a global leader in business and
19	WHEREAS, San Francisco LBEs are more likely to be headquartered in the City, hire
20	local residents, provide union wages, and contribute to the well-being and stability of our
21	communities; and
22	WHEREAS, San Francisco values and supports union projects that promote fair wages
23	and safe working conditions and recognizes the importance of requiring Project Labor
24	Agreements (PLAs) to ensure equitable outcomes; and

1	WHEREAS, The San Francisco Administrative Code, Chapter 14B, emphasizes the
2	inclusion, support, and prioritization of San Francisco LBEs, Disadvantaged Business
3	Enterprises (DBEs), and Small Business Enterprises (SBEs) in City contracts and
4	procurement processes; and
5	WHEREAS, The San Francisco Board of Supervisors supports the Contract Monitoring
6	Division (CMD) Director in ensuring the fair and equitable implementation of Chapter 14B
7	policies; and
8	WHEREAS, The City and County of San Francisco is committed to fostering
9	partnerships that prioritize the inclusion of San Francisco LBEs, SBEs, and DBEs in local,
10	state, and federally funded projects; and
11	WHEREAS, All businesses operating in San Francisco should actively collaborate with,
12	partner with, and include San Francisco LBEs in their purchasing, procurement, and
13	construction efforts to ensure equitable access to opportunities; and
14	WHEREAS, The City and County of San Francisco believes that prioritizing local
15	businesses and residents creates more value and opportunity for the community, strengthens
16	the City's economic foundation, and reinforces its commitment to inclusiveness, expanding
17	opportunities for small businesses, and recognizing that diversity makes us stronger; now,
18	therefore, be it
19	RESOLVED, That the San Francisco Board of Supervisors expresses its unwavering
20	support for San Francisco LBEs and their right to work and thrive in the City they call home;
21	and, be it
22	FURTHER RESOLVED, That the Board of Supervisors calls upon all businesses
23	seeking to operate in San Francisco to actively include, collaborate with, and partner with San
24	Francisco LBEs to the fullest extent possible; and, be it

1	FURTHER RESOLVED, That the Board of Supervisors reaffirms its commitment to
2	ensuring that San Francisco LBEs are given primary consideration in City contracts and
3	procurement, that San Francisco DBEs are prioritized for federally funded projects, and that
4	San Francisco SBEs are similarly given first consideration; and, be it
5	FURTHER RESOLVED, That the Board of Supervisors supports union projects and the
6	signing of Project Labor Agreements to uphold fair wages and strong labor protections
7	throughout the City and County of San Francisco; and, be it
8	FURTHER RESOLVED, That the San Francisco Board of Supervisors reaffirms its
9	belief in the values of inclusiveness, economic opportunity, and diversity as a strength,
10	ensuring that small businesses have access to meaningful opportunities that contribute to the
11	prosperity of San Francisco; and, be it
