[Commending the First San Francisco Summit on Immigrant Rights]

Resolution commending the San Francisco Immigrant Rights Commission for organizing the First San Francisco Summit on Immigrant Rights.

WHEREAS, A considerable number of San Francisco residents are foreign-born individuals who have immigrated to the United States; and

WHEREAS, These foreign-born individuals often face a challenging quality of life due to economical, social, and cultural differences; and

WHEREAS, The San Francisco Immigrant Rights Commission is working to improve the quality of life for San Francisco's immigrants by holding its First San Francisco Summit on Immigrant Rights, which is to take place on September 14, 2002; and

WHEREAS, The First San Francisco Summit on Immigrant Rights will set the stage for initiating policy changes that will improve the quality of life for San Francisco's immigrants; and

WHEREAS, The First San Francisco Summit on Immigrant Rights will consist of discussion sessions covering issues such as employment, housing, healthcare access, discrimination, hate crimes, and refugees and economic issues; and

WHEREAS, The First San Francisco Summit on Immigrant Rights will provide an opportunity for productive collaboration by bringing together officials of city, state and federal governments and commissions, leaders of community-based organizations that primarily work

with immigrants, and members of the general public interested in the well-being of the immigrant community; and

WHEREAS, The First San Francisco Summit on Immigrant Rights will provide networking and collaboration opportunities for the public and private sectors to address problems in a full range of immigrant issue areas; and

WHEREAS, The First San Francisco Summit on Immigrant Rights will provide education for attendees to exchange and update information on ways to best serve our immigrant community; and

WHEREAS, The First San Francisco Summit on Immigrant Rights will provide the strategic planning of a three-year course of action for positive changes in immigrant issues and related policies; and

WHEREAS, The First San Francisco Summit on Immigrant Rights will address the problem of duplication and gaps in services available to immigrants across private and public sectors and the necessity for city-wide coordination and a regular survey of services in all sectors available to all immigrants by collecting data from all immigrant-related service agencies, programs, and key individuals across all sectors; and,

WHEREAS, The First San Francisco Summit on Immigrant Rights will be a practical means towards optimizing the utilization of the limited resources available to the immigrant community; and

WHEREAS, The First San Francisco Summit on Immigrant Rights will provide a Recognition of Excellence in Community Service and Leadership Awards to those individuals

and organizations serving various immigrant populations within the San Francisco immigrant community; and

WHEREAS, On the occasion of the First San Francisco Summit on Immigrant Rights, the San Francisco Immigrants Rights Commissions also celebrates its 5th year anniversary; and

WHEREAS, The First San Francisco Summit on Immigrant Rights will serve as a model for future work; now, therefore be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco commends the San Francisco Immigrant Rights Commission for organizing the First San Francisco Summit on Immigrant Rights.
