8 WHEREAS, On May 18, 2008, the City and County of San Francisco ("City")
9 enacted Ordinance No. 126-18, which added Administrative Code, Chapter 107 to
10 create a process for the establishment of cultural districts in the City to acknowledge
11 and preserve neighborhoods with unique cultural heritage; and

12 WHEREAS, Administrative Code, Section 107.3 set forth a list of established
13 Cultural Districts (as defined in Administrative Code, Section 107.1) of the City and
14 County of San Francisco: Japantown Cultural District; Calle 24 (Veinticuatro) Latino
15 Cultural District; SoMa Pilipinas – Filipino Cultural Heritage District; Transgender
16 Cultural District; Leather and Lesbian, Gay, Bisexual, Transgender, Queer (LGBTQ)
17 Cultural District; African American Arts and Cultural District; Castro Lesbian, Gay,
18 Bisexual Transgender, and Queer (LGBTQ) Cultural District; American Indian Cultural
19 District; and Sunset Chinese Cultural District; and

20 WHEREAS, Administrative Code, Section 107.5 requires the Mayor's Office of
21 Housing and Community Development ("MOHCD") to prepare a Cultural, History,
22 Housing, and Economic Sustainability Strategy Report ("CHHESS") report for each
23 Cultural District following the process set forth in Section 107.4(b)(5)-(7); and

24 WHEREAS, Administrative Code, Section 107.4(b)(7) requires MOHCD to submit
25 the CHHESS report to the Board of Supervisors for adoption by Resolution; and




