WHEREAS, Based upon evaluation of responses to a California Integrated Waste Management Board request for proposals in the area of Sustainable Buildings, the Department of the Environment's Green Building Program was selected to be the recipient of \$25,000 in funding to use recycled-content rubber surfaces in the Golden Gate Concourse Underground Parking facility; and,

WHEREAS, the Department of the Environment's Green Building Program is responsible for implementation of the City and County of San Francisco's Resource Efficient Building Ordinance; and,

WHEREAS, The Resource Efficient Building Ordinance requires the maximum reuse and recycling of building materials; and,

WHEREAS, The Resource Efficient Building Ordinance created a Pilot Program to demonstrate innovative building materials; and,

WHEREAS, The Golden Gate Concourse Underground Parking facility is a Green Building Pilot Project; and,

WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now, therefore, be it;

RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget; and be it

2 Underground Parking Facility by the Board of Supervisors, the San Francisco Board of
3 Supervisors authorizes the Director of the Department of the Environment to accept and
4 expend funding of \$25,000 from the California Integrated Waste Management Board for a
5 project that will incorporate recycled tire rubber surfaces in the Golden Gate Concourse
6 Underground Parking Facility.
