9 WHEREAS, The San Francisco Giants Community Fund (Fund) and the Good Tidings
10 Foundation (Foundation) wish to make an in-kind gift to the City in the amount of \$100,000 in
11 the form of costs for materials and physical labor to complete improvements to the Recreation
12 and Park Department's Excelsior Playground baseball/softball field, and

13 WHEREAS, As a part of this project The Fund and Foundation wish to provide funding
14 and labor to complete the removal and replacement of the existing sod, lay new cinder and
15 clay on the infield, and install irrigation heads that will provide sufficient water coverage to the
16 entire field; and,

17 WHEREAS, The Fund and Foundation wishes to replace existing fence material with
18 vinyl fencing for the backstop and dugouts, replace the anchors for the bases, replace home
19 plate and the pitchers mound and rubber, and install new player benches; and

20 WHEREAS, The Fund wishes to improve on the appearance and message of the mural
21 along the first base wall of the facility with one created by Giants player Omar Vizquel with the
22 firm of Precita Eyes; now, therefore, be it

24 **RESOLVED, That the General Manager of the Recreation and Park Department is**
25 **hereby authorized to accept and expend an in-kind gift in the amount of \$100,000 from the**
San Francisco Giants Community Fund and the Good Tidings Foundation.
