1           1.       Use is authorized as long as an independent evaluator, selected by the Planning  
2 Department with input from parties, determines that the information and conclusions  
3 submitted by AT&T in support of its request for conditional use are accurate. AT&T shall fully  
4 cooperate with the evaluator and shall provide any and all data requested by the evaluator to  
5 allow the evaluator to verify that the maps, data, and conclusions about service coverage  
6 submitted by AT&T are accurate. AT&T shall bear all costs of said evaluation. The  
7 independent evaluator, upon request by AT&T, shall keep the submitted data confidential and  
8 shall sign a confidentiality agreement acceptable to AT&T. The independent evaluator shall  
9 be a professional engineer licensed by the State of California.
