

1 [Consolidation of Special Municipal Election with Special Statewide Election Scheduled for -  
2 June 7, 2011]

3 **Resolution calling a Special Municipal Election for June 7, 2011, and consolidating that**  
4 **election with the Statewide Special Election anticipated to be held on the same date.**

5  
6 WHEREAS, The Governor of the State of California may call a statewide special  
7 election for June 7, 2011; and

8 WHEREAS, The Department of Elections has received two local propositions for  
9 submission at the next election, both of which are on file with the Clerk of the Board of  
10 Supervisors in File No.110121, which is hereby declared to be a part of this motion as if set  
11 forth fully herein; and

12 WHEREAS, Additional propositions may be submitted to the Department of Elections in  
13 time for submission to the voters at a June 7, 2011, election; and

14 WHEREAS, The Board of Supervisors believes that it is in the best interests of the  
15 public that the election on any local propositions awaiting submission to the voters be  
16 consolidated with the June 7, 2011 Statewide Special Election, if a statewide election is called  
17 for that date; now, therefore, be it

18 RESOLVED, That a Special Municipal Election is called and ordered to be held in the  
19 City on Tuesday, the seventh day of June, 2011, for the purpose of submitting to the electors  
20 of the City any propositions that have been submitted to the Department of Elections in time  
21 for submission to the voters at that election; and, be it

22 FURTHER RESOLVED, That pursuant to Elections Code 10400 et seq., the Special  
23 Municipal Election to be held in the City and County of San Francisco on June 7, 2011, shall  
24 be and hereby is consolidated with the Special Statewide Election, if the statewide election is  
25 called by the Governor of California for the same date; and be it

1 FURTHER RESOLVED, That this call for a Special Municipal Election is contingent on  
2 the State of California holding a Statewide Special Election on June 7, 2011, and this  
3 resolution shall be repealed by operation of law if a Statewide Special Election is not called for  
4 that date;

5 FURTHER RESOLVED, That if the Governor calls a Statewide Special Election that is  
6 consolidated with the Special Municipal Election as set forth herein, then the voting precincts,  
7 polling places, and officers of the Special Municipal Election and Special Statewide Election  
8 shall, in every case, be the same; all candidates, ballot measures and bond proposals shall be  
9 set forth on the ballots provided for said election; the elections shall be held in all respects as  
10 though there were only one election, and all returns shall be canvassed by the Director of  
11 Elections as provided in the California Elections Code; and be it

12 FURTHER RESOLVED, That this resolution may be withdrawn by a majority vote of  
13 the Board of Supervisors.




