8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Findings.

10 The Planning Department has determined that the actions contemplated in this  
 11 Ordinance are in compliance with the California Environmental Quality Act (California Public  
 12 Resources Code sections 21000 et seq.). Said determination is on file with the Clerk of the  
 13 Board of Supervisors in File No. \_\_\_\_\_ and is incorporated herein by reference.

14 Section 2. The San Francisco Park Code is hereby amended by amending Section  
 15 12.36, to read as follows:

16 **SEC. 12.36. ATHLETIC FIELD FEES ~~FOR ADULTS~~.**

9 (c) Not for Profit Fees are available to organized programs that serve San Francisco  
10 residents and that do not generate income or compensation to the organizers and/or  
11 sponsors. The Commission shall establish criteria for the determination of organizations  
12 eligible for this fee. Organizations shall pay an application fee of \$150.00 for certification for  
13 eligibility for Not For Profit Fees.

14 (d) For Profit Fees apply to organized programs that generate income or  
15 compensation to organizers, fundraisers or subsidies to other programs. The Commission  
16 shall establish criteria for the determination of organizations subject to this fee.
