

1 [Approval of Agreement between the City and County of San Francisco and Cubic  
2 Transportation Systems, Inc. for Farebox System Rehabilitation and Upgrades, for a contract  
term of twenty-six (26) months and an amount not-to-exceed \$19,000,000.]

3 **Resolution approving the Agreement between the City and County of San Francisco,**  
4 **through the San Francisco Municipal Transportation Agency, and Cubic Transportation**  
5 **Systems, Inc. for Fare System Rehabilitation and Upgrades Project.**

7 WHEREAS, The existing fare collection equipment and software, (the farebox system)  
8 on all SFMTA revenue vehicles have exceeded their ten (10)-year design life and must be  
9 rehabilitated and upgraded in order to sustain system reliability and improve customer service;  
10 and,

11 WHEREAS, The SFMTA Board of Directors determined that it was in the public's best  
12 interest to award the "Agreement between the City and County of San Francisco and Cubic  
13 Transportation Systems, Inc. for Farebox System Rehabilitation and Upgrades " (Farebox  
14 System Rehabilitation Agreement), a new twenty-six (26) month contract to rehabilitate and  
15 upgrade the farebox system, as a sole source contract to Cubic Transportation Systems, Inc.  
16 and authorized the Executive Director/CEO to execute the Agreement which is also on file  
17 with the Clerk of the Board of Supervisors in File No. 081003; and

18 WHEREAS, The farebox system software and hardware are proprietary to Cubic  
19 Transportation Systems, Inc. and therefore, no other vendor can provide parts or software for  
20 the system, and no other farebox system can easily integrate into the SFMTA's existing  
21 farebox system, which was purchased from Cubic seventeen (17) years ago; and

22 WHEREAS, The Human Rights Commission has approved a sole source contract  
23 waiver for the Farebox System Rehabilitation and Upgrades project. Said determination is on  
24 file with the Clerk of the Board of Supervisors in File No. 081003 and is  
25 incorporated herein by reference; and

1           WHEREAS; The SFMTA has recommended the Farebox System Rehabilitation  
2 Agreement to the Board of Supervisors for its review and approval; now, therefore, be it

3           RESOLVED, That Board of Supervisors approves the Agreement in support of the  
4 Farebox System Rehabilitation and Upgrades project for a term of twenty-six (26) months and  
5 an amount not-to- exceed \$19,000,000.


