3 **Ordinance authorizing settlement of the lawsuit filed by Armin Abdollahvand against**
4 **the City and County of San Francisco for \$50,000; the lawsuit was filed on**
5 **August 27, 2019, in San Francisco Superior Court, Case No. CGC-19-578732; entitled**
6 **Armin Abdollahvand v. City and County of San Francisco, et al.; the lawsuit involves an**
7 **alleged personal injury in a rear-end automobile collision involving a City employee.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Armin Abdollahvand v. City and
12 County of San Francisco, San Francisco Superior Court, Case No. CGC-19-578732 by the
13 payment of \$50,000. The lawsuit involves an alleged personal injury in a rear-end automobile
14 collision involving a City employee.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 August 27, 2019, and the following parties were named in the lawsuit: Armin Abdollahvand,
17 Plaintiff; City and County of San Francisco and Todd A. Sucey, Defendants.
