of California to be the Director of the State Employment Development

WHEREAS, From 1979 to 1986, Mr. Bernick worked with the San  
Francisco Renaissance Center, an inner city job training and economic  
development agency that operates literacy and vocational training  
classes, training for older workers, welfare-to-work training and an  
entrepreneurship center; and,

WHEREAS, For over 20 years, Mr. Bernick has served as an  
executive director or board member for community employment and  
training programs including the Ella Hill Hutch Community Center,  
Parents of Success, Youth for Service and the Mission Reading Clinic;  
and,

WHEREAS, Michael Bernick is also the author of three books on  
employment and economic development; and,

WHEREAS, In addition to his other commitments, Mr. Bernick has  
been practicing law in San Francisco since 1986; now, therefore, be  
it

1           RESOLVED, That the Board of Supervisors of the City and County  
2 of San Francisco recognizes Michael Bernick's expertise in and  
3 commitment to the field of employment and training; and, be it

4           FURTHER RESOLVED, That the Board of Supervisors of the City and




