Subject: Assessment for Blight Corrections

Dear Members of the Board:

Chapter 80 of the Administrative Code requires property owners to maintain their property in safe condition and blight-free. The department inspects periodically and notifies the property owner of blighted conditions which must be corrected. Property owners are billed \$250 inspection fee pursuant to Chapter 80 of the Administrative Code. Also, property owners may elect to have the Department make necessary corrections and have associated costs placed on their next property tax bill.

If the property owner fails to pay the inspection fee and/or fails to make the correction, the work is done by the City, and the property owner is billed. If the property owner fails to pay the inspection bill and /or the abatement bill, an assessment in the amount of the bill is submitted to the Board of Supervisors.

Enclosed for your review and approval are:

- 1. A list of various properties that have either chosen to have work performed by the Department of Public Works (DPW) and have elected to have abatement costs placed on their next property tax bill and/ or property owners who have failed to reimburse DPW for inspection fee.
- 2. A resolution confirming the Order.

The Department has conducted twelve public hearings throughout the year prior to commencing any work on behalf of a property owner. During these hearings, property owners can dispute the area required for repair and associated costs. After review and approval by the Board of Supervisors, the assessment is added to the property owner's tax bill.
