[Settlement of Lawsuit - Robert Brown - \$119,909]

Ordinance authorizing settlement of the lawsuit filed by Robert Brown against the City and County of San Francisco for \$119,909; the lawsuit was filed on August 13, 2016, in United States District Court, Case No. 16-CV-04671; entitled Robert Brown v. City and County of San Francisco et al.; the lawsuit involves claims of alleged civil rights violation.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Robert Brown v. City and County of San Francisco, et al., United States District Court, Case No. 16-CV-04671 by the payment of \$119,909, which includes attorney's fees. The lawsuit involves alleged civil rights violations.

Section 2. The above-named action was filed in United States District Court on August 13, 2016, and the following parties were named in the lawsuit: plaintiff: Robert Brown; Defendants City and County of San Francisco, Officer Brent M. Cader #704, Officer David E Rodriguez #156, Officer, Gabriel Alcaraz, #590, Sergeant, Daniel J. Cole #1135.


