2 Department of Corrections]

3 **Resolution authorizing the San Francisco SHERIFF or his designee to enter into**
4 **contract with the California Department of Corrections (CDC) for the provision of a**
5 **Substance Abuse Treatment and Control Unit (SATCU) in the City and County of San**
6 **Francisco when Parole and Community Services Division personnel conclude that**
7 **there are reasonable grounds for believing that a parolee is addicted to, or habituated**
8 **to, or is in imminent danger of addiction to controlled substances or alcohol.**

9 WHEREAS, the County Facility is designated as a SATCU pursuant to provisions of
10 Health and Safety Code (H&S) Section 11560; and,

11 WHEREAS, when Parole and Community Services Division personnel conclude that
12 there are reasonable grounds for believing that a parolee is addicted to, or habituated to, or is
13 in imminent danger of addiction to controlled substances or alcohol, the parolee may be
14 placed in the County Facility SATCU in a non-suspended status under H&S Section 11561
15 (male) or 11563 (female) for a period not to exceed 90 days; and,

16 WHEREAS, under the terms of Agreement No. P03.0045, the County Facility will
17 provide secure housing for up to 30 days for SATCU parolees while participating in intensive
18 substance abuse treatment; and,

19 WHEREAS, the term of this Agreement shall commence March 1, 2004 and terminate
20 no later than June 30, 2006; and,

21 WHEREAS, the maximum amount of the agreement shall not exceed the sum of
22 \$1,508,040; now, therefore, be it

23 RESOLVED, That the San Francisco County Sheriff, or his designee, is hereby
24 authorized and directed to execute the Standard Agreement, Contract # P03.0045, for the

1 provision of inmate housing, in the form hereto attached, on behalf of the County of San
2 Francisco, with the State of California, California Department of Corrections and to do and
3 perform everything necessary to carry out the purpose of this resolution.


