4 LAGUNA HONDA HOSPITAL, TO ACCEPT AND EXPEND GRANT FUNDS OF \$693,750 FROM  
5 THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) FOR THE LAGUNA  
6 HONDA ASSISTED LIVING/HOUSING FOR SENIORS PROJECT AND TO ENTER INTO AN  
7 AGREEMENT WHICH DOES NOT INCLUDE INTELLECTUAL PROPERTY INDEMNIFICATION  
8 AND FALSE CLAIMS CLAUSES.

9 WHEREAS, The Department of Public Health has applied for and been awarded a grant from  
10 HUD, in the amount of \$693,750, for the Laguna Honda Assisted Living/Housing for Seniors Project;  
11 and,

12 WHEREAS, As a condition of receiving the grant funds, HUD requires the City to enter into  
13 an agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors  
14 in File No. 001129; and

15 WHEREAS, The Agreement does not contain certain provisions described below, which are  
16 required under the Administrative Code unless waived by the Board of Supervisors; and,

17 WHEREAS, The grant budget includes provision for indirect costs of <sup>\$42,000</sup>~~\$12,200~~; now, therefore,  
18 be it

19 RESOLVED, That the Department of Public Health is hereby authorized to accept and expend  
20 the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and, be it

21 FURTHER RESOLVED, That the Director of Health is authorized to enter into the Agreement  
22 on behalf of the City; and, be it
