9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Leonard Lee Collins, Jr. v. City and  
12 County of San Francisco, Laguna Honda Hospital, Edward Shiels, Steven Koneffklatt, et. al.,  
13 U.S. District Court (N.D.Cal.), Case No. 13-3456 MEJ by the payment of \$75,000.

14 Section 2. The above-named action was filed in the United States District Court for the  
15 Northern District of California on December 18, 2012, and the following parties were named in  
16 the lawsuit: Leonard Lee Collins, Jr., Plaintiff, and the City and County of San Francisco,  
17 Laguna Honda Hospital, Edward Shiels, and Steven Koneffklatt, Defendants.


