2 **Resolution determining that the transfer of a Type 48 on-sale general public**

8 WHEREAS, Pavel Vicevich is seeking transfer of a Type 48 on-sale general  
9 public premises license for dba “Red Eye” located at 1337 Mission Street; and,

10 WHEREAS, The City Planning Department has verified that the area is properly  
11 zoned; and,

12 WHEREAS, The Police Department recommends that the liquor license  
13 application be approved with conditions; now, therefore, be it

14 RESOLVED, That in accordance with Section 23958.4 of the California Business  
15 and Professions Code, the Board of Supervisors of the City and County of San  
16 Francisco hereby determines for the foregoing reasons that the transfer of a Type 48  
17 on-sale general public premises license from 1489 Folsom Street to 1337 Mission  
18 Street for Pavel Vicevich for dba “Red Eye”, will serve the public convenience and  
19 necessity of the people of the City and County of San Francisco.

20 Conditions: 1) Sales and service of alcoholic beverages shall be permitted only  
21 between the hours of 4:00 p.m. and 2:00 a.m. each day of the week; 2) Entertainment  
22 provided shall not be audible beyond the area under the control of the licensee; 3) The  
23 petitioner(s) shall be responsible for maintaining free of litter the area in front of and  
24 adjacent to the premises over which they have control.




