2 Center]

3 **Resolution approving the Sixth Amendment to the Treasure Island Fire Fighting**
4 **Training Center Master Lease between the Treasure Island Development Authority and**
5 **the United States Navy to extend the term for one year for the period of December 1,**
6 **2014, through November 30, 2015.**

8 WHEREAS, The Treasure Island Development Authority ("Authority") and the United
9 States of America, acting by and through the Department of the Navy (the "Navy"), entered
10 into a master lease dated December 19, 1997, for the Authority to use and sublease certain
11 land and structures comprising the former Naval Fire Fighting Training Center on Treasure
12 Island (as amended from time to time, the "Fire Fighting Training Center Master Lease") at no
13 rent; and

14 WHEREAS, The Master Lease and Amendments No. 1 through 4 are on file with the
15 Clerk of the Board of Supervisors in File No. 121009 and Amendment No. 5 is on file with the
16 Clerk of the Board of Supervisors in File No. 130907; and

17 WHEREAS, The Fire Fighting Training Center Master Lease enables the San
18 Francisco Fire Department to utilize the master leased area for interim use associated with
19 fire-fighting training activities; and

20 WHEREAS, The term of the Fire Fighting Training Center Master Lease expires on
21 November 30, 2014; and

22 WHEREAS, The Authority wishes to extend the term of such lease for a period of one
23 (1) year beginning on December 1, 2014, and ending on November 30, 2015, unless sooner
24 terminated in accordance with the terms and conditions of the Master Lease; and

1 WHEREAS, The Navy concurs with such amendment and the amendment has been
2 approved by the Authority Board of Directors at its July 9, 2014, meeting; and

3 WHEREAS, The Board of Supervisors Resolution establishing the Authority; AB 699
4 and TIDA's Bylaws require that the Authority obtain Board of Supervisors approval of any
5 agreements having a term in excess of ten (10) years or anticipated revenues of \$1,000,000
6 or more; and

7 WHEREAS, Because the cumulative term of the Fire Fighting Training Center Master
8 Lease exceeds ten (10) years, the Authority is requesting that the Board of Supervisors
9 approve the Sixth Amendment to extend the term of such lease for a period of one (1) year
10 beginning on December 1, 2014, and ending on November 30, 2015, unless sooner
11 terminated in accordance with the terms and conditions of the Master Lease; now, therefore,
12 be it

13 RESOLVED, That the Board of Supervisors hereby approves and authorizes the
14 Director of Island Operations of the Authority or her designee to execute and enter into the
15 Sixth Amendment to the Fire Fighting Training Center Master Lease in substantially the form
16 filed with the Clerk of the Board of Supervisors in File No. 140863, and any additions,
17 amendments or other modifications to such Sixth Amendment (including, without limitation, its
18 exhibits) that the Director of Island Operations of the Authority or her designee determines, in
19 consultation with the City Attorney, are in the best interests of the Authority and do not
20 otherwise materially increase the obligations or liabilities of the Authority, and are necessary
21 or advisable to effectuate the purpose and intent of this resolution; and, be it

22 FURTHER RESOLVED, That within thirty (30) days of Amendment No. 6 being fully
23 executed by all parties, the Authority shall provide the final Amendment No. 6 to the Clerk of
24 the Board for inclusion into the official file.



Resolution Approving the Sixth Amendment to the Treasure Island Fire Fighting Training Center Master Lease between the Treasure Island Development Authority and the United States Navy to Extend the Term.

SUMMARY OF PROPOSED ACTION:

This item seeks approval and authorization to amend the Master Lease between the Treasure Island Development Authority (the "Authority") and the U.S. Navy (the "Navy") for the Fire Fighting Training Center on former Naval Station Treasure Island to extend the Term of the Lease to November 30, 2015.

BACKGROUND:

On December 19, 1997 the Treasure Island Development Authority ("Authority") entered into Lease Number N6247498RP00P22 with the United States Navy (as amended from time to time, the "Fire Fighting Training Center Master Lease"). The lease premises include land and structures utilized by the San Francisco Fire Department ("SFFD") as a Fire Training Facility. The Authority does not pay any Base Rent under the Fire Fighting Training Center Master Lease. The Master Lease is renewed yearly.

The term of the Fire Training Center Master Lease will expire November 30, 2014. The proposed Sixth Amendment extends the term through November 30, 2015 on the same terms and conditions as the existing Fire Fighting Training Center Master Lease.

The Authority's Board of Directors approved the Sixth Amendment to the Fire Fighting Training Center Master Lease at its July 9, 2014 meeting. Pursuant to the Board of Supervisors Resolution establishing the Authority, AB 699 and TIDA's Bylaws, Board of Supervisors approval is required of any contract or agreement entered into by the Authority with a term longer than ten years. Because the term of the Fire Fighting Training Center exceeds ten years, the Director of Island Operations requests approval of the Sixth Amendment from the Board of Supervisors to extend the term to November 30, 2015 on the same terms and conditions as the existing Master Lease.

RECOMMENDATION:

Approve the Sixth Amendment to the Treasure Island Fire Fighting Training Center Master Lease between the Treasure Island Development Authority and the United States Navy to extend the term to November 30, 2015.

**SIXTH AMENDMENT
TO LEASE AGREEMENT N6247498RP00P22
BETWEEN
THE UNITED STATES OF AMERICA
AND
TREASURE ISLAND DEVELOPMENT AUTHORITY**

THIS LEASE AMENDMENT made this ____ day of _____ 2014, by and between the UNITED STATES OF AMERICA, acting by and through the Department of the Navy, hereinafter called the "Government", and the TREASURE ISLAND DEVELOPMENT AUTHORITY, hereinafter called the "Lessee";

WHEREAS, the parties hereto, as of 19 December 1997, entered into Lease Agreement N6247498RP00P22 under the terms of which the Lessee uses certain real property for space located at the former Naval Station, Treasure Island; and

WHEREAS, the parties agree to amend the terms of the Lease Agreement.

NOW THEREFORE, in consideration of the terms, covenants and conditions hereinafter set forth; the following paragraphs to Lease N6247498RP00P22 are hereby amended to reflect the following changes;

1. Paragraph 2 **TERM**, delete in its entirety and the following paragraph is inserted therefore:

"The term of this Lease shall be for a period of one (1) year beginning on 1 December 2014 and ending on 30 November 2015, unless sooner terminated in accordance with the provisions of Paragraph 14, Termination."

All other terms and conditions of the Lease Agreement shall remain in full force and effect.

IN WITNESS WHEREOF, the parties hereto have, on the respective dates set forth above duly executed this amendment to the Lease as of the day and year first above written.
