

1 [Administrative Code - Cole Valley Entertainment Zone]

3 **Ordinance amending the Administrative Code to create the Cole Valley Entertainment**  
4 **Zone on Cole Street, between Frederick Street and Parnassus Avenue, and on Carl**  
5 **Street, between Shrader Street and Clayton Street; to delete the requirement that an**  
6 **Entertainment Zone Event be a special event permitted or licensed by the California**  
7 **Department of Alcoholic Beverage Control; and affirming the Planning Department's**  
8 **determination under the California Environmental Quality Act.**

14 Be it ordained by the People of the City and County of San Francisco:

16 Section 1. CEQA Findings.

17 The Planning Department has determined that the actions contemplated in this  
18 ordinance comply with the California Environmental Quality Act (California Public Resources  
19 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of  
20 Supervisors in File No. \_\_\_\_ and is incorporated herein by reference. The Board affirms this  
21 determination.

23 Section 2. Chapter 94B of the Administrative Code is hereby amended by revising  
24 Sections 94B.1 and 94B.4, to read as follows:

1 **SEC. 94B.1. DEFINITIONS.**

2 For the purposes of this Chapter 94B, the following definitions shall apply:

4 (c) "Entertainment Zone Event" means ~~an special~~ event ~~permitted or licensed by ABC~~ that  
5 occurs within the boundaries of an Entertainment Zone established in accordance with this  
6 Chapter 94B and within the hours permitted by this Chapter 94B and the Management Plan or  
7 the Downtown Activation Permit issued pursuant to Administrative Code Chapter 94D for the  
8 Entertainment Zone.

10 **SEC. 94B.4. ENTERTAINMENT ZONE LOCATIONS.**

12 (b) **Additional Entertainment Zones.**

14 **(3) Cole Valley Entertainment Zone.**

15 All public streets, public rights-of-way, and sidewalks in front of storefronts abutting  
16 both sides of Cole Street, between Frederick Street and Parnassus Avenue, and abutting both sides of  
17 Carl Street, between Shrader Street and Clayton Street, and all establishments holding permits or  
18 licenses from ABC that are located on either side of said locations, are hereby designated as the Cole  
19 Valley Entertainment Zone under Sections 23039.5 and 25690 of the California Business and  
20 Professions Code.

21 (c) Except as otherwise specified in this Section 94B.4, an Entertainment Zone  
22 Event must receive a permit for the use of a public street under Transportation Code Division  
23 I, Section 6.6 or 6.16 or Transportation Code Division II, Section 206, or other applicable  
24 authority of the SFMTA.

1 (d) Outdoor consumption of alcoholic beverages within this Entertainment Zone is  
2 authorized during any Entertainment Zone Event on any day of the year between the hours of  
3 noon and 11:59 p.m., inclusive, subject to any additional limitations imposed by any ABC  
4 permit or license and by the Management Plan, or if none, the Downtown Activation Permit,  
5 for the Entertainment Zone, including but not limited to more restrictive days and hours during  
6 which outdoor consumption of alcoholic beverages is authorized.

7 (e) A Downtown Activation Permit is not required to hold an Entertainment Zone  
8 Event.

9  
10 Section 3. Effective Date. This ordinance shall become effective 30 days after  
11 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
12 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
13 of Supervisors overrides the Mayor's veto of the ordinance.

14  
15 Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors  
16 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,  
17 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal  
18 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment  
19 additions, and Board amendment deletions in accordance with the "Note" that appears under  
20 the official title of the ordinance.
