3 **Resolution authorizing the Municipal Transportation Agency to accept and expend**
4 **\$744,000 of Federal Building Fund grant funds from the U.S. General Services**
5 **Administration for the Municipal Railway's Radio System Replacement Project,**
6 **excluding administrative overhead costs.**

8 WHEREAS, The Director of the Budget, US General Services Administration (GSA), is
9 authorized to make monies available through GSA's Federal Building Fund for capital
10 assistance; and

11 WHEREAS, The Municipal Transportation Agency (MTA), City and County of San
12 Francisco, is an eligible claimant for GSA capital assistance projects under the Federal
13 Building Fund; and

14 WHEREAS, No local share of project costs is required under this grant; and

15 WHEREAS, In connection with the filing of an application for federal assistance, the
16 applicant must give an assurance that it will comply with Title VI of the Civil Rights Act of
17 1964; and

18 WHEREAS, It is the goal of the applicant that Disadvantaged Business Enterprises
19 (DBEs) be utilized to the fullest extent possible in connection with this project, and that
20 definitive procedures shall be established and administered, consistent with federal law, to
21 ensure that DBEs shall have maximum opportunity to compete for contracts, supplies,
22 equipment contracts, or consultant and other services; and

23 WHEREAS, Congress has dedicated funding at GSA for a national program of projects
24 using Federal Building Fund capital assistance; and


1 WHEREAS, The Municipal Railway's (Muni's) Radio System Replacement project,

10 necessary to complete transfer of the funds




