4 **County of San Francisco for \$900,000; the lawsuit was filed on January 5, 2022, in San**  
5 **Francisco Superior Court, Case No. CGC-22-597432; entitled R.C. v. City and County of**  
6 **San Francisco, et al.); the lawsuit involves an alleged sexual assault by a City**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled R.C. v. City and County of San  
12 Francisco, et al.), San Francisco Superior Court, Case No. CGC-22-597432 by the payment  
13 of \$900,000. The lawsuit involves an alleged sexual assault by a City employee.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 January 5, 2022, and the following parties were named in the lawsuit: plaintiff R.C.; defendant  
16 City and County of San Francisco.
