3 **Resolution authorizing the San Francisco Department of Public Health to accept and**
4 **expend retroactively a grant from the California Department of Alcohol and Drug**
5 **Programs in the amount of \$370,182 to fund the Substance Abuse Offender Treatment**
6 **Program for the period July 1, 2009, through June 30, 2010.**

8 WHEREAS, DPH was awarded a grant from the ADP in the amount of \$370,182 for a
9 project entitled "Substance Abuse Offender Treatment Program (OTP);" for the period of July
10 1, 2009 through June 30, 2010; and,

11 WHEREAS, The purpose of this grant is to allow DPH to provide residential substance
12 abuse treatment services for approximately 133 clients; and,

13 WHEREAS, As required by the funder, \$41,131 in matching funds from local general
14 funds will be allocated toward this project; and,

15 WHEREAS, DPH will subcontract with the Walden House, Inc., in the amount of
16 \$41,131 for the period of July 1, 2009 through June 30, 2010; and,

17 WHEREAS, DPH is seeking retroactive approval because DPH did not receive the
18 grant award until March 3, 2010; and,

19 WHEREAS, The budget does not include a provision for indirect costs in order to
20 maximize the use of grant funds on direct services; now therefore, be it

21 RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant
22 in the amount of \$370,182 from the ADP; and, be it


23 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
24 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,

FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget; and be it


FURTHER RESOLVED, That the Director of Health is authorized to enter into the agreement on behalf of the City.




