8 WHEREAS, The people of the State of California have enacted the CALIFORNIA  
9 CLEAN WATER, CLEAN AIR, SAFE NEIGHBORHOOD PARKS AND COASTAL  
10 PROTECTION ACT OF 2002 which provides funds for the Roberti-Z'Berg-Harris Block Grant  
11 Program for grants to eligible Applicants, and

13 WHEREAS, The California Department of Parks and Recreation has been delegated  
14 the responsibility for the administration of the program within the State, setting up necessary  
15 procedures, and

16 WHEREAS, Said procedures established by the California Department of Parks and  
17 Recreation require the Applicant's Governing Body to certify by resolution the approval of the  
18 Applicant to apply for the Roberti-Z'Berg-Harris allocation; and

20 WHEREAS, The Applicant will enter into a Contract with the State of California for the  
21 Project; and


22 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now  
23 therefore be it

24 RESOLVED, That the San Francisco Board of Supervisors authorizes the Recreation

1 and Park Department to accept and expend funds available under The Roberti-  
2 Z'berg-Harris Block Grant Program under the California Clean Water, Clean Air, Safe  
3 Neighborhood Parks, and Coastal Protection Act of 2002 in the amount of \$4,742,243; and

5 FURTHER RESOLVED That the San Francisco Board of Supervisors hereby:  
6 Approves the acceptance and expenditure of local assistance funds from the Roberti-  
7 Z'berg-Harris Block Grant Program under the California Clean Water, Clean Air, Safe  
8 Neighborhood Parks and Coastal Protection Act of 2002; and Certifies that the Applicant has  
9 or will have sufficient funds to operate and maintain the Project(s); and Waives inclusion of  
10 indirect costs in the grant budget; Certifies that the Applicant has reviewed, understands, and  
11 agrees to the General Provisions contained in the Contract shown in the Procedural Guide;  
12 and Certifies that the Project conforms to the recreation element of any applicable city or  
13 county general plan; and Appoints the General Manager of the Recreation & Park  
14 Department as agent to conduct all negotiations, execute and submit all documents including,  
15 but not limited to, Applications, agreements, payment requests and so on, which may be  
16 necessary for the completion of the Project.




