14	Section 1. Chapter 5 of the Administrative Code is hereby amended by adding Artic	
15	XVIII, consisting of Sections 5.18-1 through 5.18-7, to read as follows:	
16	ARTICLE XVIII:	
17	GRAFFITI ADVISORY BOARD	
18		
19	SEC. 5.18-1. CREATION OF ADVISORY BOARD.	
20	The Board of Supervisors ("Board") hereby establishes the Graffiti Advisory Board (the	
21	"Advisory Board").	
22		
23	SEC. 5.18-2. PURPOSE.	
24	The purpose of the Advisory Board is to advise the Board and the Mayor on issues relating to	
25	the prevention and abatement of graffiti in San Francisco.	

1	SEC. 5.18-3. MEMBERSHIP.
2	The Advisory Board shall consist of 15 voting members, appointed as follows:
3	(a) Seats 1-11 shall be held by persons appointed by individual Members of the Board, with
4	each Member of the Board making one appointment. To be eligible for appointment to Seats 1-11, an
5	individual must (1) be an officer or employee of an organization that provides services to youth
6	involved in graffiti diversion programs; (2) be an officer or employee of an organization with
7	experience in City beautification and/or neighborhood cleanup programs; (3) own real property
8	located in San Francisco; (4) own a business located in San Francisco; or (5) have previously served
9	on the Graffiti Advisory Board. Appointments to Seats 1-11 shall be effective when written notice of the
10	appointment is received by the Clerk of the Board of Supervisors.
11	(b) Seat 12 shall be held by the Mayor or the Mayor's designee.
12	(c) Seat 13 shall be held by the Director of Public Works or the Director's designee.
13	(d) Seat 14 shall be held by the Chief of Police or the Chief's designee.
14	(e) Seat 15 shall be held by the Director of Cultural Affairs, or the Director's designee.
15	
16	SEC. 5.18-4. ORGANIZATION AND TERMS OF OFFICE.
17	(a) Members of the Advisory Board shall serve at the pleasure of the member's appointing
18	authority and may be removed by the appointing authority at any time.
19	(b) Any member in Seats 1-11 who misses three regular meetings of the Advisory Board
20	within a six-month period without the express approval of the Advisory Board at or before each missed
21	meeting shall be deemed to have resigned from the Advisory Board ten days after the third unapproved
22	absence. The Advisory Board shall inform the Board of Supervisors of any such resignation.
23	(c) The Department of Public Works shall provide administrative support for the Advisory
24	<u>Board.</u>

1	(d) As set forth in the Board's Rules of Order, if the Clerk of the Board of
2	Supervisors determines that the Advisory Board has not met at least once every four months
3	in the prior year, the Clerk may ask the City Attorney to prepare legislation to terminate the
4	Advisory Board.
5	
6	SEC. 5.18-5. DUTIES.
7	The Graffiti Advisory Board shall have the duty to:
8	(a) By October 1, 2024, and every year thereafter, prepare and submit to the Board and the
9	Mayor a report addressing the impacts of graffiti on neighborhoods and the downtown area of San
10	Francisco, reviewing and evaluating the services and programs in place to prevent graffiti and respond
11	to graffiti, and making recommendations for strategies to consolidate public and private anti-graffiti
12	efforts;
13	(b) Advise the Board and the Mayor about the coordination of information, activities, and
14	goals among existing graffiti prevention and graffiti abatement programs; and
15	(c) Advise the Board and the Mayor about ways to make the graffiti prevention and
16	abatement services more efficient.
17	
18	SEC. 5.18-6. MEETINGS AND PROCEDURES.
19	(a) The Advisory Board shall hold its inaugural meeting not more than 60 days after the
20	effective date of the ordinance in Board File No enacting this Article XVIII. There shall be
21	at least ten days' public notice of the inaugural meeting. Following the inaugural meeting, the
22	Advisory Board shall hold a regular meeting not less than once each month.
23	(b) The Advisory Board shall elect a chair and such other officers as it deems appropriate,
24	and may establish bylaws and rules for its organization and procedures.
25	

1	<u>SEC. 5.18-7. SUNSET.</u>
2	Unless the Board of Supervisors by ordinance extends the term of the Advisory Board, this
3	Article XVIII shall expire by operation of law, and the Advisory Board shall terminate, three years after
4	the effective date of the ordinance in Board File No. 231004 enacting this Article. In that event, after
5	the sunset date, the City Attorney is authorized to cause this Article XVIII to be removed from the
6	Administrative Code.
7	
8	Section 2. Effective Date. This ordinance shall become effective 30 days after
9	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
10	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
11	of Supervisors overrides the Mayor's veto of the ordinance.

[Administrative Code - Establishing Graffiti Advisory Board]

Ordinance amending the Administrative Code to establish the Graffiti Advisory Board to advise the Board of Supervisors and the Mayor on issues relating to graffiti prevention and abatement; and setting forth the membership and duties of the Advisory Board.

Existing Law

Currently, there is no advisory body that advises the Board of Supervisors (Board) or the Mayor on issues relating to graffiti prevention and abatement.

Amendments to Current Law

The proposed ordinance would establish the Graffiti Advisory Board (Advisory Board), which would be responsible for advising the Board and the Mayor on issues relating to graffiti prevention and abatement.

The Advisory Board would consist of 15 members, 11 of whom would be appointed by individual Members of the Board of Supervisors. The remaining four seats would be held by the Mayor, Director of Public Works, Chief of Police, and the Director of Cultural Affairs, or their designees.

By October 2024, and every year thereafter, the Advisory Board would be required to prepare and submit to the Board and the Mayor a report addressing the impacts of graffiti on neighborhoods and the downtown area of San Francisco, reviewing and evaluating the services and programs in place to prevent graffiti and respond to graffiti, and making recommendations for strategies to consolidate public and private anti-graffiti efforts.

Background Information

In 1993, the City established the Graffiti Advisory Board to advise the Board of Supervisors about the problem of graffiti in neighborhoods and the downtown area of San Francisco. The legislation establishing the Advisory Board sunset in March 2022, so as of the introduction of this ordinance, there has been no Graffiti Advisory Board in place for approximately 18 months. Before sunsetting in 2022, the Advisory Body consisted of 25 members.
