WHEREAS, The entertainment industry plays a vital role in sustaining California's economy and past legislation enacted in 1985 created the California Film Commission, currently existing within the Business, Transportation and Housing Agency, to facilitate, retain, and attract filming in California; and,

WHEREAS, The Board of Supervisors recognizes that film, television, and commercial production activity contributed \$34.3 billion to California's economy in 2002 and sustains more than 245,000 job; and,

WHEREAS, over fourteen other states and many nations have created film incentive programs that lure films and their related good paying union jobs from California; and,

RESOLVED, That the City and County of San Francisco supports Assembly Bill 777 creating a California state tax credit for qualified motion pictures and urges its swift passage and approval by the Governor; and, be it

FURTHER RESOLVED, That the Board of Supervisors directs the Clerk of the Board to forward a copy of this resolution to members of our state legislative delegation.
